Dear Licensee,

The time has come to renew your License for Ministry. As you know, once a year the Nurturing and Credentialing Committee (NACC) and the Ministry Commission has each licensed minister and Mentor / Calling Cohort fill out separate progress reports as part of the license renewal process. Please fill out your form thoughtfully, completely, and prayerfully.

Remember, you are responsible for initiating meetings with your Calling Cohort (at least four times a year). The Mentor / Calling Cohort Report is a key element in the decision that the NACC and the Ministry Commission will use in your being re-licensed for the next year, 2021. You may want to take time as well to review (the copy you saved at home) of your current Covenant of Accountability. If there are changes, send them to the district office.

Also, please note that your church board, or church council needs to vote to reaffirm your licensing by October 1, 2019. The letter to your congregation will remind them of this requirement. If you hold a (paid / unpaid) position in your church (such as pastor, associate pastor, chaplain, youth leader...), the following forms must also be returned by your church:
